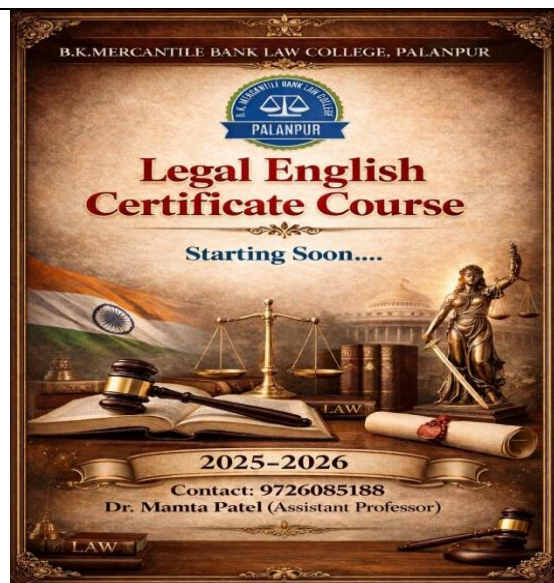

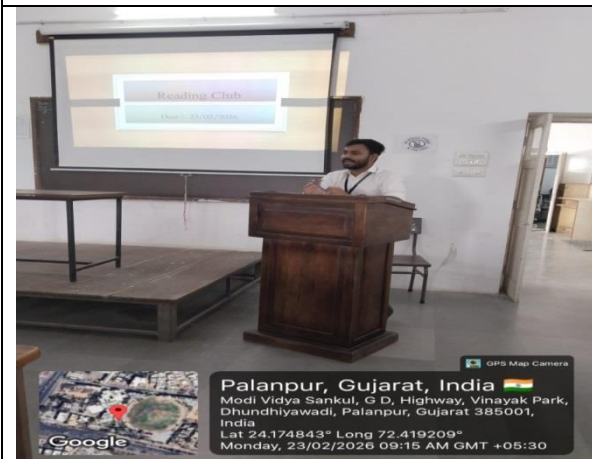


**Date:- 20/02/2026 to 24/02/2026
